

OVERVIEW OF THE PINK SHRIMP FISHERY WOC

- Specie: Pandalus Jordani
- Catch area: Washington, Oregon, California
- Season: April 1st October 31st
- Soft mud and sandy ocean floor
- Life cycle typically 3 years

Pink Shrimp Management Guidelines - Size & Season

- Minimum count per pound
 - Average 160 count per LB or better
 - Typical range of size from 80 to 150 count per LB
- Harvest is conducted around the spawning season
 - April 1st to October 31st each season
- No Quota
- VMS (Vessel Monitoring System)
- NMFS observer coverage



WOC PINK SHRIMP


- Each State manages the fishery independently and responsible for
 - > Fish Tickets
 - Biology
 - > Enforcement
- All three states manage the resource around season and size
- All three states maintain good cooperation and exchange of information.







ANNUAL WOC PINK SHRIMP LANDINGS BY STATE





Pink Shrimp Landing by WOC Main Ports

- **Westport, WA** 9797 MT up 56% from 6285 MT in 2020
- **Astoria, OR** 5888 MT up 6% from 5573 MT in 2020
- **Newport, OR** 7864 MT up 25% from 6290 MT in 2020
- **Charleston, OR** 3672 MT up 6% from 3452 MT in 2020
- **Brookings, OR** 3406 MT down 15% from 4008 MT in 2020

• **CA** – 0 MT








Figure 10. The percentage of 2021 catch by area.

MSC CERTIFICATION

- 2007: Oregon state fishery receives MSC certification
 - First wild caught shrimp fishery in the world to receive MSC certification
- 2013: Oregon state fishery recertified
- 2015: Washington state fishery receives MSC certification
- 2018: Oregon and Washington recertified
- 2021: California will likely going into assessment and become the third state to achieve MSC certification for Pink Shrimp
- 2022: 4th Surveillance Audit is underway with California expected to be awarded the MSC certification





Outlook 2022

- Reports toward end of 2021 Season:
 - Good carry over indication of age 0 & 1 year age shrimp
- Water Conditions: El Nino conditions low, strong presence of La Nina which indicates a good cold water current and good shrimp conditions!
- We would expect that volume for 2022 season ought to be similar to that of 2021.
